This Writ Petition is filed seeking for a direction to the respondent to issue non-traceable certificate to the petitioner.

2.It is submitted by learned counsel for the petitioner that the petitioner has lost original document bearing No.1256/1972 dated 28.10.1972, on which, in order to get a photocopy of the document from the concerned Sub Registrar Office, the petitioner has filed an application dated 07.07.2023 before the respondent Police to issue non traceable certificate and the said petition is pending.

3. Learned Government Advocate (Criminal Side) submitted that on account of non-appearance of the petitioner, the police could not dispose of the application and could not provide necessary certificate.
