2. It is evident from the records that this Court, vide order dated 04.01.2023, directed the trial Court to dispose of the suits within a period of eight months from the date of receipt of copy of that order.

The learned Additional District Judge, Sivagangai, has submitted a requisition dated 05.03.2024 stating that when the suit was pending for examination of the plaintiff side further witnesses, the defendants have filed an application to receive the additional written statement and the same was allowed on 21.02.2024 and subsequently commission application came to be filed in I.A.No.4 of 2024 and the same is pending and seeks three months further time to dispose of the suit.

4. Considering the reasons assigned, this Court is inclined to grant time as sought for by the learned Additional District Judge. Accordingly, three months further time is granted to dispose of the suits from the date of receipt of a copy of this order.
