PETITION FOR BAIL Under Sec.439 of Cr.P.C.

PRAYER :- For Bail in Crime No.155 of 2023 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner/Sole Accused, who was arrested on 29.08.2023 for the alleged offence under Section 328 IPC r/w. Sections 6(4), 24(1) of Cigarette and other Tobacco Products Act, 2003, in Crime No.155 of 2023, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that on 29.08.2023, the respondent Police along with the Police party were on patrol duty in the areas under Sattur Taluk Police Station jurisdiction and at around 3.00 p.m., they reached the petitioner's petty shop located at Santhana Mariamman Koil Street in Ameerpalayam, where, the petitioner was found in illegal possession of banned tobacco products in a white sack bag and the same was seized by the respondent Police along with cash of Rs.1,790/-. Hence, the case.

3. The learned counsel for the petitioner would submit that the petitioner is an innocent and she never committed any such offences as alleged by the prosecution. The petitioner is in custody from 29.08.2023. Hence, prays to release her on bail.

4. The learned Additional Public Prosecutor for the respondent Police submitted that there is no previous case pending against the petitioner.

5. Considering the nature of offence and also considering that there is no previous case pending against and the period of incarceration, this Court is inclined to grant bail to the petitioner with certain conditions.

6. Accordingly, this Criminal Original Petition is allowed and the petitioner is ordered to be released on bail, on executing a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.II, Sattur, Virudhunagar District, and on
