Learned Government Advocate (Criminal Side) submits that, the complaint filed by the third respondent against the petitioners is still pending and as per the complaint there are disputes between the petitioners and the unofficial respondents in respect of money transaction and further submitted that, within a short time, the respondent Police will complete the enquiry.

4. Considering the submissions made by both sides and on perusal of records, this criminal original petition is disposed of, directing the respondent Police to complete the enquiry as quickly as possible not later than two weeks from the date of receipt of a copy of this order.
