Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified mandamus calling for the records pertaining to the order passed by the 3rd respondent in his proceedings in Na.Ka.No.702/ A4/2018 dated 15/11/2018 and quash the same and direct the respondents to approve the appointment of the petitioner as Secondary Grade Teacher with effect from 01/06/2012 with consequential benefits.
