The learned counsel for the petitioner would submit that by the order dated 14.08.2023 in Crl.M.P.No.4022 of 2023, the order has been passed by the Principal District and Sessions Judge, Virudhunagar at Srivilliputhur, imposing Rs.2,00,000/- as cost upon the petitioner. Since, the petitioner is very poor, he could not comply the above said condition. Hence, he seeks modification to the above said condition.

3. Taking into consideration of the submissions made by the learned counsel for the petitioner, the condition No.1 imposed by the learned Principal District and Sessions Judge, Virudhunagar at Srivilliputhur, in Crl.M.P.(MD) No.4022 of 2023, dated 14.08.2023 is modified to the effect that the petitioner is directed to deposit a sum of Rs.10,000/- to the District Mediation Centre, Virudhunagar District at Srivilliputhur, instead of Rs.2,00,000/-. Hence, this Criminal Original Petition is ordered.
