3.The learned counsel for the petitioner submitted that the petitioner is an innocent person and she has not committed any offence as alleged by the prosecution. Only to invoke Act 14, this case has been registered against the petitioner.

4.The learned Additional Public Prosecutor would submit that the petitioner is having 21 previous cases. Proposal dated 08.09.2023, is pending with the respondent police to invoke Act 14 against the petitioner.

5.In view of the above, the petitioner is at liberty to revive his application, if no order is passed on the above said proposal within a reasonable time.

6.With the above said liberty, this criminal original petition stands dismissed.
