3. Learned Counsel for the petitioners would submit that the petitioners are innocents, they have not committed any offence as alleged by the prosecution and they have been falsely implicated in this case.

4. Learned Additional Public Prosecutor would submit that the earlier application of the petitioners seeking bail, was dismissed by this Court, by considering the grievous nature of the offences.

5. Considering the facts and circumstances and also the fact that the earlier bail application of the petitioners was dismissed, I find no change of circumstances in this case. Accordingly, this Criminal Original Petition is dismissed.
