Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records relating to the impugned rejection order in No.13198/ThaKu.4/2023 dated 31.08.2023 on the passed by the of the Respondent No.4 and quash the same as illegal and consequently directing the Respondents to grand 28 days of Ordinary Leave to the petitioners husband by name Doss @ Vattakkan @ Perumal @ Petha Perumal S/o. Perumal aged 33 years, now confining at Trichy Central Prison as Life Convict for conjugal visit and for medical treatment to the petitioner for Jaundice and to provide necessary treatment to the petitioners husband for the bone fracture.
