ORDER

2.Expressing and fearing the life of the petitioner at the hands of the accused in Crime No.411 of 2017 on the file of the Pudukkottai Police Station, Thoothukudi District, which is pending before the learned Principal District Judge, Thoothukudi, for trial, the petitioner has given a representation before the respondent Police Station. Now it is stated to be pending before them. He is the star witness in the above said case.

3.Let the above said representation be disposed of by the respondent police on its own merits and in accordance with law, within a week from the date of receipt of a copy of this order, by summoning the petitioner as well as the counter parties and after ascertaining the ground situation as to whether any real life threat exists at the hands of counter parties. Depending upon the enquiry, the
