4.The learned Government Advocate submitted that the petitioner along with other accused found in possession of the contraband, which is in commercial quantity. The petitioner is having four previous cases. There is no change in circumstances. Hence, prays to dismiss the petition.

5. Considering the facts and circumstances of this case and also the submission of the learned Additional Public Prosecutor that no change in circumstances, this Court is not inclined to grant bail to the petitioner.

6.Accordingly, this Criminal Original Petition is dismissed.
