This Writ Petition is filed for a Certiorarified Mandamus, to call for the impugned order passed by the 2nd respondent dated 21.09.2023 in Na.Ka.No.71/Mike/D2PS/2023 and quash the same as illegal and direct the 2nd respondent to give permission and protection to perform the Adal Padal on 27.09.2023 in respect of the temple festival of “Purattasi Thiruvizha” in “Arulmigu Manthaiamman Thirukovil”, situated at Kusavapatti, Perungudi, Madurai District.

2.It is submitted by the learned counsel for the petitioner that the petitioner and other villagers have been conducting the festival every year including the Aadal Paadal programme, but the respondent police have declined to grant the permission as per proceedings dated 21.09.2023 in Na.Ka.No. 71/Mike/D2PS/2023 and therefore, sought for suitable directions.

3.The learned Government Advocate (Crl.side) after taking instructions from the concerned police has reported that the respondent police have no objection to grant the permission to the petitioner for conducting the Aadal Paadal programme on 27.09.2023 in connection with the Purattasi Thiruvizha of Arulmigu Manthaiamman Thirukovil at Kusavapatti, Perungudi, Madurai.
