This criminal original petition has been filed seeking direction to the 1st respondent to withdraw the pending investigation in Crime No.133 of 2023 dated 07.08.2023 on the file of the 2nd respondent Police based on the representation of the petitioner dated 12.08.2023 and to entrust the same to the 3rd Respondent Police for conducting enquiry within the time stipulated by this Court and also to give Police Protection for the petitioner.

2.Seeking transfer of investigation on the ground that no proper investigation has been undertaken by the respondent this petition came to be filed. The learned Government Advocate (Crl. Side) would submit that investigation has been completed and final report has been filed before the Additional Mahila Court, Trichy on 02.09.2023. But, so far it has not been taken on file.
