ORDER

This Criminal Original Petition has been filed seeking direction to the respondents 1 to 3 to provide adequate police protection for the petitioner and his family members.

3.The particulars of the civil Court are not available in the enquiry file. Whatever may be, due to the noncooperation on the side of the petitioner, the above said representation has been closed. Hence, nothing survives for further consideration in this petition. This petition deserves to be dismissed. Accordingly, dismissed.
