ORDER

This Civil Revision Petition is filed seeking a direction to the Additional District Court, Periyakulam, Theni District, to dispose of the suit in O.S.No.100 of 2019 within a stipulated period.

The learned counsel appearing for the petitioner submits that the petitioner herein is the plaintiff in O.S.No.100 of 2019, which is pending on the file of the Additional District Court, Periyakulam, Theni District. She filed the said suit for partition. In that suit, pleadings have been completed and issues have also been framed, however, trial has not yet commenced. He further submits that due to the pendency of the suit, the petitioner's rights would be affected. Therefore, the petitioner is before this Court.
