The writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus, directing the respondents to remove the petitioners name from the History Sheet on the file of 3rd respondent by considering the petitioners representation dated 16.09.2023 within the period that may be stipulated by this Court.

2.The petitioner has sent a representation to the respondents to remove his name from the History Sheet on 16.09.2023. Since the same was not considered till date, he has filed this writ petition seeking a direction to consider the same by the respondents. The learned counsel for the petitioner would submit that only on the basis of the FIR registered in Crime No.395 of 2016 on the file of the third respondent police station, the history sheet was opened in respect of the petitioner. Now it is pending before the Sessions Court. It was foisted against the petitioner only due to the election motive.
