3. Mr.K.Vijayakumar, learned counsel for writ petitioner who is before us submits that captioned Writ Petition has been filed as a

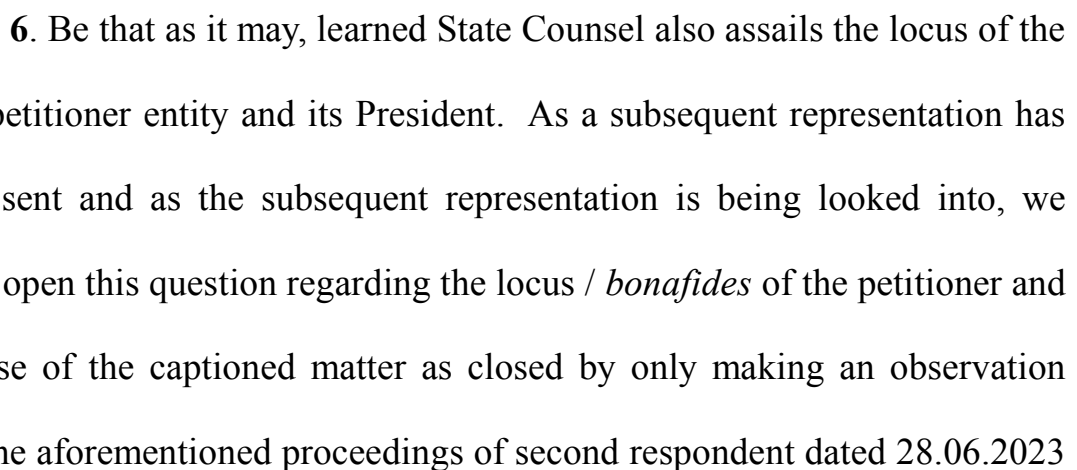
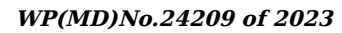

'PIL' [Public Interest Litigation] and learned counsel submits that the matter primarily pertains to Mahatma Gandhi Rural Employment Scheme. It may not be necessary to delve further into facts and be detained by factual matrix in the light of what we would be recording *infra*.

4. Issue notice. Mr.M.Senthil Ayyanar, learned Government Advocate accepts notice for respondent Nos. 1 to 4, 6 and 7. Mr.M.Karunanithi, learned Special Public Prosecutor for CBI accepts notice for respondent No. 5.

5. Mr.M.Senthil Ayyanar, learned Government Advocate, on instructions, submitted that the President of the writ petitioner entity Thiru R.Murugesan, sent a second representation, after said representation. This second representation is dated 06.06.2023 and it has been received by the second respondent on 19.06.2023. Learned State Counsel submits that acting on the same, the second respondent has directed the jurisdictional zonal officer to enquire into the matter and submit a report. Learned State Counsel has placed before us the following proceedings:
