This criminal original petition has been filed seeking to quash the FIR in Crime No.29 of 2022 on the file of the 1<sup>st</sup> Respondent Police.

2.The contention of the petitioners is that based on the complaint lodged by the 2<sup>nd</sup> respondent, the 1<sup>st</sup> respondent registered the First Information Report in Crime No.29 of 2022 for the offences punishable under Sections 294(b), 323 and 506(i) of IPC and Section 4 of TNPHW Act, 2002.

3.When the matter is taken up for hearing, the learned Government Advocate (Crl. side) would submit that after completing the investigation final report has been filed before the Additional Mahila Court, Sivagangai, and the same was taken cognizance in C.C.No.8 of 2023. Hence, the prayer sought for in this petition has become infructuous.
