3. Considering the aforesaid facts, H.M.O.P.No.40 of 2022 pending on the file of the Subordinate Court, Mudukulathur, Ramanathapuram District, is hereby withdrawn and transferred to Subordinate Court, Kovilpatti, to be tried along with H.M.O.P.No.220 of 2022.

4. With the above observation, the Transfer Civil Miscellaneous Petition is allowed to the extent as stated above. No costs. Consequently, connected Miscellaneous Petition is closed.
