4. Registry, to carry out necessary amendment in the cause title before issuing the order copy.

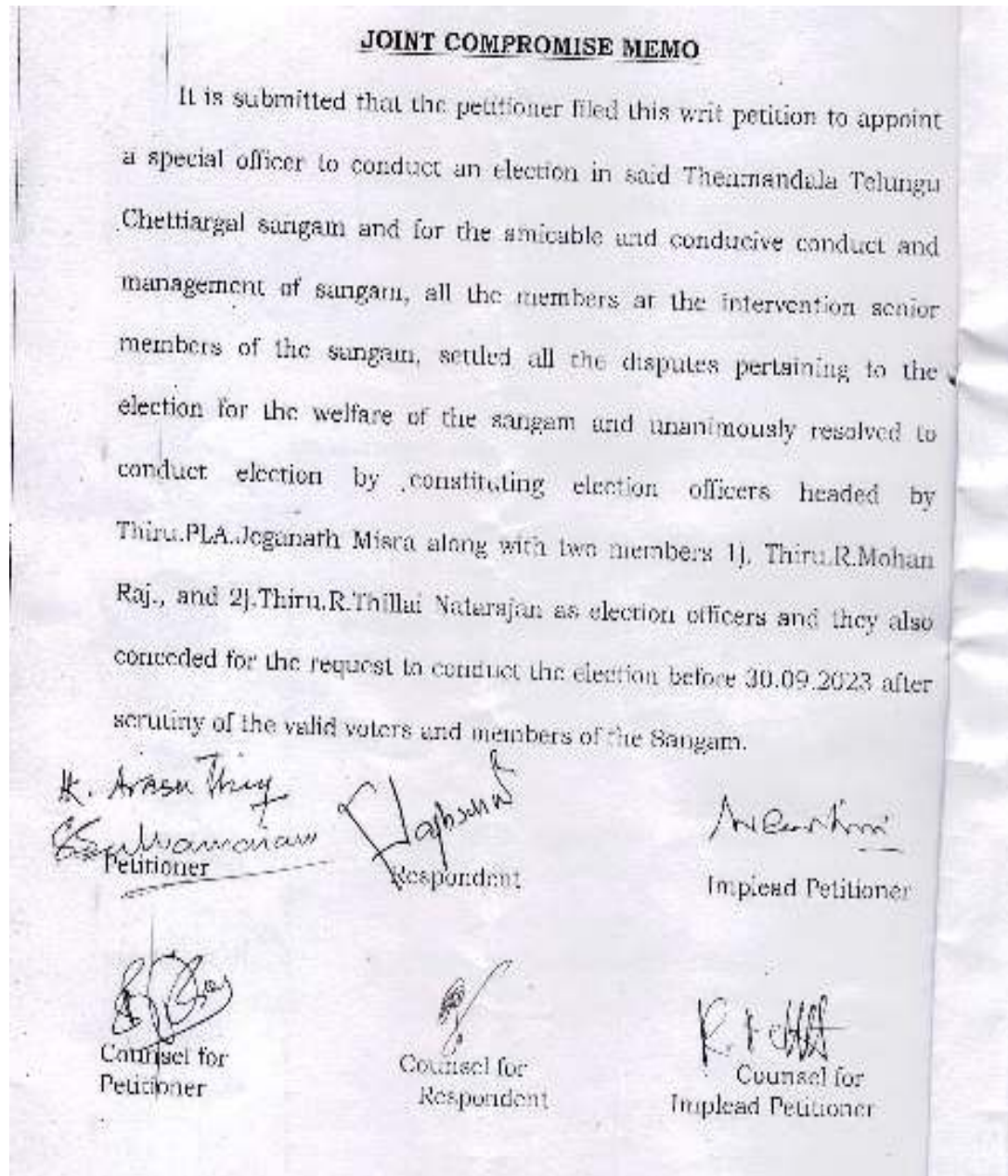
5. A joint compromise memo had been presented signed by
