Criminal Miscellaneous Petition filed under Section 482 of Cr.P.C. to relax the condition totally in Crl M.P (MD) no. 7572/2023 in Crl A (MD) No. 332 of 2023 dt. 18.05.2023.

Prayer Crl.A.(MD)No.332 of 2023:-
