3.Considering the facts and circumstances of the case, the condition already imposed on the petitioners is modified and the petitioners are directed to execute sureties before the learned Judicial Magistrate, Valliyoor, Tirunelveli District and also deposit a sum of Rs.10,000/- as directed by this Court earlier. After executing sureties, the learned Judicial Magistrate, Valliyoor is directed to send the relevant papers to the learned Judicial Magistrate No.I, Kuzhithurai, immediately. Accordingly, the Criminal Miscellaneous Petition is allowed.
