2. The case of the prosecution is that on 03.09.2023 the accused waylaid the defacto complainant and demanded money from the defacto complainant and when he refused the petitioner abused him in filthy language, attacked him with deadly weapons and thereby attempted to murder him. Hence the case.

3. The learned counsel appearing for the petitioner would contend that the petitioner is innocent and he has not committed any offence as alleged by the prosecution. He would further submit that the petitioner is in custody from 03.09.2023, hence he seek bail.

4. The learned Additional Public Prosecutor appearing for the respondent Police would submit that 11 previous cases are pending against the petitioner hence, he strongly objected to grant bail to the petitioner.
