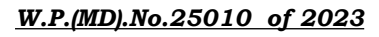

ORDER

The present Writ Petition has been filed by a Junior Engineer of the TANGEDCO seeking revocation of suspension order on the ground that it is a prolonged suspension.

2. According to the learned counsel appearing for the writ petitioner, the writ petitioner was suspended on allegations of corruption charges on 09.12.2021 and he also been implicated in Crime No.7 of 2021, which is pending trial in S.C.No.1 of 2023.

3. The petitioner has sent a representation to the first respondent herein on 26.09.2022 seeking to revoke the order of suspension on the ground that it is a prolonged suspension. The petitioner had filed a petition in W.P(MD) No. 23461 of 2022 seeking to quash the order of suspension. This Court, by an

5. With the above said observation, this Writ Petition stands disposed of. There shall be no order as to costs. Consequently connected Miscellaneous Petitions are closed.
