PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records pertaining to the impugned proceedings in Na.Ka.A2/3527/2023, dated 31.08.2023 issued by the second respondent and quash the same on the ground that the same is arbitrary, illegal and without any legal basis and consequently directing the respondents to retain the petitioner back into

ORDER

The present writ petition has been filed by the Village Administrative Officer, challenging an order of transfer.

2. A perusal of the order of transfer, dated 31.08.2023 reveals that the petitioner has been transferred from Varrapoor to Aravampatti, on administrative grounds. The petitioner is challenging the order of transfer, on the ground that it is in the middle of the academic year and there is inconvenience in shifting the family to another place.

3. The impugned order clearly points out that only on administrative grounds, the transfer is being effected.
