PETITION FOR BAIL Under Sec.439 of Cr.P.C

PRAYER :- For Bail in Crime No.459/2023 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner/accused was arrested and remanded to judicial custody on 18.02.2023 for the offences punishable under Sections 8(c) r/w. 20(b)(ii)(C), 25, 29(1) of NDPS Act, 1985 in Crime No.459 of 2023 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner herein and other accused have illegally found in possession of 15 bags of Ganja weighing about 409 Kgs. Hence, the case.

3. The learned counsel for the petitioner would submit that the petitioner is innocent and he has not committed any offence as alleged by the prosecution and his name has been falsely implicated in this case and hence, seeks bail.

4. The learned Additional Public Prosecutor appearing for the respondent would submit that the contraband recovered from the petitioner is commercial quantity and hence, he strongly opposed to grant bail to the petitioner.

5. Considering the facts and circumstances of the case and also considering the serious nature of allegations made against the petitioner, this Court is not inclined to grant bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
