ORDER

The present Writ Petition has been filed by a retired Selection Grade Conductor seeking a mandamus directing the respondents to settle the interest at the rate of 6% per annum due to the belated payment of terminal benefits. The petitioner had attained superannuation on 30.06.2022 and retirement benefits were disbursed only on 23.05.2023. The petitioner has sent a representation to the respondents on 06.07.2023, seeking interest for the said belated payment of terminal benefits.

2. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondents.

3. Considering the above said facts, the second respondent is directed to settle the interest for the belated disbursement of the terminal benefits at the rate of 6% p.a., from the date of the petitioner's retirement till the date of
