The present Writ Petition has been filed by the Special Grade Driver, who retired under Voluntary Retirement Scheme on 31.12.2021.

2. In the writ petition, the writ petitioner has prayed for payment of voluntary retirement compensation of Rs.42,708/- (Rupees Forty Two Thousand Seven Hundred and Eight only) along with interest at the rate of 6% per annum from the date of his retirement to till the date on which the said benefits were settled to him.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondents.

4. The Management has calculated the voluntary retirement compensation at Rs.42,708/- (Rupees Forty Two Thousand Seven Hundred and Eight only) at the time of his voluntary retirement. However, the said amount has not been paid so far. Therefore, the second respondent herein is directed to pay a sum of Rs.42,708/- (Rupees Forty Two Thousand Seven

Hundred and Eight only) with interest at the rate of 6% per annum from 01.01.2022 till the date of realization. The said exercise shall be completed within a period of eight weeks from the date of receipt of a copy of this order.
