ORDER

This criminal original petition has been filed to quash the charge sheet filed in C.C. No.83 of 2023 on the file of District Munsif cum Judicial Magistrate Court, Thiruppuvanam.

2.The contention of the petitioner is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.83 of 2022 for the offences punishable under Sections 294(b), 323, 506(i) of IPC r/w Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, against the petitioner.

3.The learned Government Advocate (Crl. Side) would submit that during the course of investigation the name of the petitioner has been deleted from array of accused by the order dated 12.06.2022.
