Considering the facts and circumstances of the case, this Court is inclined to grant interim stay on condition that the petitioner shall deposit 50% of the arrears amount of the maintenance pending as of now to the credit of M.C.No.1 of 2023 on the file of the Principal District Judge, Ramanathapuram, within a period of four weeks from the date of receipt of a copy of this order and further the petitioner shall pay 50% of the monthly maintenance to the respondent till the disposal of the revision case, failing which the interim stay granted shall stand vacated automatically without further reference to this Court. If on such deposit being made by the petitioner, the respondent is permitted to withdraw the deposited amount.
