2.The petitioners are the accused persons in Crime No.178 of 2023 on the file of the 2nd respondent police for the offences punishable under Sections 147, 294(b), 323, 324, 506(ii) of IPC and Sections 3(1)(r), 3(1)(s), 3(2)(va) of the

3.Mr.M.Vaikkam Karunanithi, the learned Government Advocate (Criminal Side), accepts notice for the respondents 1 and 2. 4.Considering the facts and circumstances of the case, this Court is inclined to pass the following orders :-

- 1)The petitioners shall appear before the I Additional Sessions Court (PCR), Trichy, within a period of 15 days from the date of receipt of a copy of this order.
- 2)On such surrender along with notice served to the defacto complainant, the concerned Judge shall consider the bail application filed by the petitioners and pass orders on merits on the same day of their surrender, after hearing the defacto complainant by complying with Section 15A(3) of the Act.
