According to the learned Counsel appearing for the writ petitioner, the petitioner was appointed as a B.T Assistant (Tamil) in the third respondent School on 21.06.2016 and the School had forwarded the papers to the third respondent on 24.12.2019 for approval. However, due to some dispute, her appointment is yet to be approved. The School has re-submitted the proposal to the first respondent herein on 11.08.2023 after complying with the defects pointed out by the Department.

3. In view of the above said facts, the first respondent is directed to consider the said proposal of the third respondent School on merits and in
