ORDER

Since the representation submitted by the petitioner not to permit the private respondents to put up a shed in his property in S.No.1355/1A and 1363, T.S.Ward No.2, Block No. 15, Balavinayagar Street, Avudaiyarpuram, Thoothukzudi City, was not considered, the petitioner is constrained to file the present writ petition.

2.When the matter was taken up for hearing on 19.10.2023, it was informed that a Peace Committee Meeting was scheduled to resolve the dispute between the parties.

3.Accordingly, the learned Government Advocate (Crl.Side) produced a copy of the Peace Committee Meeting. Perusal of the said
