Considering the submissions made on either side, since the petitioner is in the advanced stage of pregnancy, the petition in I.A.No.1 of 2023 in unnumbered H.M.O.P.No.____ of 2023 is ordered to be transferred from the file of the Sub Court, Sattur, Virudhunagar District to the file of the Family Court, Madurai. Accordingly, the learned Subordinate Judge, Sattur, Virudhunagar District, is hereby directed to transmit the entire records in I.A.No.1 of 2023 in unnumbered H.M.O.P.No.____ of 2023 to the file of the Family Court, Madurai, within a period of 10 days from the date of receipt of a copy of this order and after receiving the case records, the learned Judge of Family Court, Madurai, is directed to take the petition on file and refer the matter to mediation.

7. With the above direction, this Transfer Civil Miscellaneous Petition is disposed of. Consequently, connected Miscellaneous Petition is closed. No costs.
