PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :- For Anticipatory Bail in Crime No.263 of 2023 on the file of the Respondent Police.

ORDER: The Court made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police for the offences punishable under Sections 467, 468, 471 and 420 IPC in Crime No.263 of 2023, seek anticipatory bail.

2.The case of the prosecution is that the defacto complainant's grandfather had two wives and the petitioners herein are the sons of the second wife. In the year 2008, the petitioners have obtained forged legal heir certificate before the Tahsildar, Kamuthi. The defacto complainant's father died on 24.02.2019. Thereafter, the defacto complainant's brother filed a petition to cancel the above said legal heir certificate before RDO and the same was allowed. The petitioners known about the cancellation of the forged legal heir certificate. In respect of the defacto complainant's grandfather property, they have executed a partition deed by creating forged documents before the Sub-Registrar, Abiramam, on 05.09.2023. The petitioners cheated the property belongs to the defacto complainant's grandfather by way of forged documents. Hence the case.

3.The learned counsel appearing for the petitioners would submit that the petitioners are innocent persons and they have not committed any offence as alleged by the prosecution. Hence, he seeks anticipatory bail.

4.The learned Government Advocate(Crl.side) appearing for the respondent

police would submit that the accused persons, without disclosing the cancellation of legal heir certificate, registered partition deed for the common property. He would further submit that the investigation of the case is not yet completed.

5.The learned counsel appearing for the intervenor argued the matter, without filing any vakalat and petition for intervening. He would further submit that the petitioners created forged legal heir certificate and based on the same, they attempted to grab the property belongs to the defacto complainant's grandfather.

6.On perusal of records, it is noticed that the petitioners and the defacto complainant are relatives and there was a civil dispute between the parties. Now, the forged legal heir certificate was cancelled by the revenue authorities.

7.Taking into consideration the principles stated by the Honourable Supreme Court in Gurubaksh Singh Sibbia Etc., vs. State of Punjab reported in 1980 AIR 1632 and Lal Kamendra Pratap Singh vs. State of Uttar Pradesh and others reported in (2009)4 SCC 437 and Joginder Kumar vs. State of U.P. and others reported in (1994) 4 SCC 260 and taking into consideration the origin of crime, it is seen that the offence alleged as against the petitioners is not a case of heinous crime. Further the petitioners are having permanent residents at Ramanathapuram District. Hence the principles stated in Hussainara Khatoon & Ors vs. Home Secretary, State Of Bihar reported in AIR 1979 SC 1360 is taken into consideration. In that case, the Hon'ble

Supreme Court has cautioned that pre-trial detention is not to be encouraged nor is to be encourageable pre-trial release on sureties; that if the Court is satisfied after taking into consideration that the accused has his roots in the community and is not likely to abscond, he can safely be released on his personal bond.

8. In view of the above, this Court is inclined to grant anticipatory bail to the petitioners. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance, within a period of fifteen days from the date on which the order copy is made ready, before the learned Judicial Magistrate, Kamuthi, Ramanathapuram District on condition that the petitioners shall execute a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that :

[a] the petitioners shall affix his photograph and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar Card or Bank Pass Book to ensure their identity.

[b] the petitioners shall report before the trial Court on summons.

[c] the petitioners shall not tamper with evidence or witness either during investigation or trial.

[d] the petitioners shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
