2.Today, when the matter was taken up for hearing, the learned counsel for the petitioner submitted that the conditional interim order of this Court dated 02.12.2022 has been complied with and the petitioner has paid a sum of Rs.50,000/- to the respondents. He further submitted that the petitioner is ready to settle the remaining outstanding amount as on date to the respondents within a period of four months, for which, the learned counsel for the respondents is also

agreeable, however, seeks liberty to proceed further in accordance with law, if the petitioner fails to settle the remaining amount within the time stipulated.
