17.07.1995 passed by the 1st respondent in respect to the Kamatchipuram and Seepalakottai Village Panchayats and relating to the impugned order in Na.Ka.No.4831/2021/Q3, dated 21.09.2022 and Na.Ka.No.19070/2022/Q3 dated 23.09.2022 passed by the 1st respondent and quash the same insofar as the allotment of the amount to Seepalakottai panchayat in respect of Survey Nos.827/1,2,3 and 828 and consequently direct the 1st respondent reallocate the quarry income to the Kamatchipuram Panchayat.
