Prayer in Crl OP(MD)SR.No.40969 OF 2022:

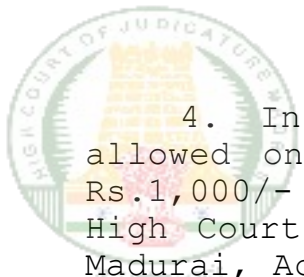

The above Criminal Miscellaneous Petition has been filed seeking orders to condone the delay of 176 days in filing the Criminal Revision challenging the judgment passed in C.C.No.232 of 2019 dated 03.12.2021 on the file of the Judicial Magistrate No.1, Ramanathapuram.
