The prayer in the writ petition is for issuance of a Writ of Mandamus, directing the respondents 1 to 3 to remove the encroachment made by the 4th respondent in Survey No.308/23, North South Cement Road, based on the petitioner's representation dated 14.02.2022 within a time frame.

2. Today, when the writ petition was taken up for hearing, learned Government Pleader appearing for the official respondents produced the proceedings of the 3rd respondent in Na.Ka.No. 102/2022/B3 dated 22.12.2022 and submitted that there is no encroachment by the 4th respondent in the pathway in question as

alleged by the petitioner. As per the revenue records, patta has been issued to the 4th respondent for an extent of 506 sq.ft in S.No.308/18 which is not connected to the pathway in question.

3. Recording the above submission, the Writ Petition is dismissed. No costs.
