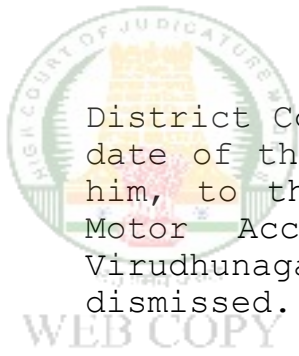

District Court, Virudhunagar, within a period of four weeks from the date of this order, after deducting the amount already deposited by him, to the credit of M.C.O.P.No.131 of 2016, on the file of the Motor Accident Claims Tribunal - Additional District Court, Virudhunagar, failing which, stay granted shall stand automatically dismissed.
