2. It is evident from the records that this Court, vide order dated 10.01.2023, directed the learned District Munsif, Tiruchendur, to dispose O.S.No.90 of 2018, within a period of eight months from the date of receipt of copy of that order.

Now, the learned District Munsif, Tiruchendur, has submitted a requisition dated 03.11.2023 stating that the plaintiff has filed an application to scrap the Commissioner's report in I.A.No.3 of 2023 and the same is pending, that interlocutory application in I.A.No.325 of 2018 is pending for clarification and that due to the above circumstances, he could not dispose of the suit.
