This petition has been filed seeking direction to the 1st respondent to register a criminal case based on the order passed by the learned Judicial Magistrate, Nilakottai in Crl.M.P.No.4226 of 2023, dated 04.07.2023.

2.By the order dated 04.07.2023 in Crl.M.P.No.4226 of 2023 filed by the petitioner under Section 156(3) Cr.P.C., the learned Judicial Magistrate, Nilakottai, directed the first respondent to register a criminal case on the basis of the complaint lodged by the petitioner. But, so far the first respondent has not comply the above said order. Hence, this petition.

3.The learned Government Advocate (Crl.
