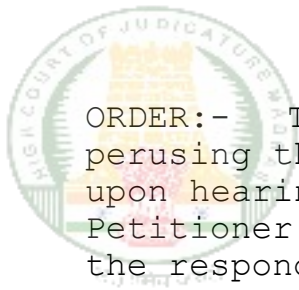
Sub Application filed under Section 151 of C.P.C. To reopen the Cont Petition (MD) No.1511 of 2022 and take action to punish the respondent for his wilful and deliberate disobedience to the order of this Court dated 28.02.2022 in W.P.(MD) No.18420 of 2021.

Prayer in Cont. P(Md) No.1511 of 2022

Contempt Petition filed under Section 11 of the Contempt of Courts Act, 1971 to punish the Contemnor/ respondent for his willful and deliberate disobedience to the orders of this Honourable Court in W.P. (MD). No. 18420 of 2021 dated 28.02.2022.

Prayer in WP(MD). 18420/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a WRIT OF MANDAMUS or any other order or directions in the nature of a writ directing the respondent i.e., the Commissioner of Treasuries and Accounts, Chennai to arrange to disburse the medical expenses of Rs.42,331/- (Rupees Forty Two Thousand Three Hundred and Thirty One Only) incurred by the petitioner under Medical Attendance Rules as per the directions of the State Level Empowered Committee in O.Mu.No.2489/Kapil/2020 Dt. 22.04.2021, within a specified time frame.



ORDER:- This Petition coming on for orders on this day on perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Thiru.S.Visvalingam, Advocate for the Petitioner and of Mr.S.P.Maharajan, Special Government Pleader, for the respondents, this Court made the following order:
