2. By order dated 16.12.2022, statutory notice was directed to be issued to the respondent. Pursuant thereto, today, the respondent is present before this Court and has filed a status report stating that pursuant to the order passed in the aforesaid writ petition, a survey was conducted in S.No.219/9, wherein, it was found that two persons have encroached upon the said survey number which has been classified as road.
