Considering the submissions made by the learned Additional Government Pleader, this writ petition stands disposed of, with a direction to the fifth respondent to consider and pass orders on the representation of the petitioner dated 06.02.2017, on merits and in accordance with law, after issuing a fresh notice of enquiry to the petitioner, within a period of twelve weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
