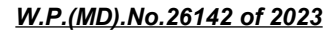

ORDER

The present writ petition has been filed by an Electrician Grade – I, who was working in the second respondent Municipality seeking a Mandamus as against the second respondent to implement the orders of the first respondent, dated 21.03.2023 and the consequential order of the second respondent, dated 24.03.2023.

2. The appointment of the writ petitioner as Electrician Grade – I was ratified by the order of the first respondent, dated 21.03.2023 with effect from 28.12.1990. This ratification order was followed by the second respondent by issuing proceedings for releasing the increments by passing an order on 24.03.2023.
