PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to pay the petitioner interest at the rate of 6% per annum, for the period of delay from 01.07.22 to 30.05.23, in paying the amounts paid towards his terminal and pension benefits namely EPF Employee's Contribution, Gratuity, Encashment of Leaves and Commuted Value of Pension, within a time frame as may be fixed by this Court and without affecting his right to claim balance amounts towards those benefits.

3. In view of the above said facts, the respondents are directed to pay interest at the rate of 6% from 01.07.2022 till the date of realisation within a period of twelve (12) weeks from the date of receipt of copy of this order.
