ORDER

Hence, he has sent a representation to the respondent on 03.06.2023. Since the representation has not been considered, the present writ petition has been filed.

2. Heard the learned counsel appearing for the petitioner and the learned Standing counsel appearing for the respondents.

3. In view of the above said facts, if the petitioner is eligible for the surrender leave salary, the same shall be disbursed to the petitioner. This Court directs the second respondent to disburse the said benefits, if he is otherwise eligible, within a period of 12 (Twelve) weeks from the date of receipt of a copy of this order.
