### **ORDER**

The present writ petition has been filed seeking a Mandamus to pay interest for the belated disbursement of the terminal benefits.

2. According to the writ petitioner, he retired as a Special Grade Driver on 31.05.2022. His terminal benefits were disbursed to him after one year, namely on 30.05.2023. Seeking interest for the belated payment, the petitioner has sent a representation on 24.06.2023. Since there is no response from the respondents, the present writ petition has been filed.

3. Considering the above said facts, the 1<sup>st</sup> respondent is directed to pay interest at the rate of 6% for the period of delay from 31.05.2022 to 30.05.2023 within a period of twelve (12) weeks from the date of receipt of a copy of this order.
