This criminal original petition has been filed seeking direction to the learned Judicial Magistrate, Uthapamalayam, to recall the warrant dated 26.10.2023 in Crl.M.P.No.5384 of 2023 in M.C.No.17 of 2022.

2.The learned counsel for the petitioner would submit that the second respondent filed M.C.No.17 of 2022 before the trial Court, wherein, Rs.10,000/- was ordered to be paid by the petitioner to the second respondent.
